We look ahead – Pandemic Plan

We are continuously working for you and have taken precautions in the event that employees at LBG are directly affected by the "Corona Virus" or administrative measures ("quarantine", location closure) are ordered.

- LBG offices across Austria: LBG has 31 locally independent locations across Austria, including two in the capital City of Vienna - Vienna-Landstrasse and Vienna-Donaustadt. If one of our locations is closed by the authorities, we switch to the resources of other locations.
- Employee flexibility in the event of a crisis: We work and train across Austria according to uniform technical and organizational standards and support this through the exchange of experience within the framework of the "LBG Academy". This means that a large number of employees are available in every LBG business area in order to continue the necessary work for our customers despite possible "corona disease". For example, almost 150 of our approximately 530 employees work in the business area "Payroll Accounting, Wage Tax, Social Insurance, Labor Law" according to uniform standards and ensure the correct accounting and timely payment of wages and salaries for around 30.000 employees of our clients per month. The same applies to our business areas "Financial Statements, Finance and Accounting", "Tax and Business Consulting" and "Digitization and Commercial Organization".
- IT organization & technology: To ensure data security and data protection, we operate our own data processing center at the location in Vienna-Arsenal - deliberately separated from all operating LBG offices, which meets the highest security standards in Austria. In addition, we have set up a separate "emergency data center". Our IT experts at LBG manage the data processing center and the whole IT technology and work at various LBG locations in order to prevent default risks - optimally coordinated with modern communication tools. We have taken the best possible precautions for corona-related troubles.
